The 'Leaders List'

One of the first Citywealth products was a "leaders list." It was launched because the industry thrives on a circle of cross referrals and a trusted network of individuals who are both wealth managers and advisers. We asked the global private wealth industry to open its little black books and to share that trusted network with us. This produced the first list of leaders who exclusively deal with UHNW clients.

The Citywealth Magic Circle Awards

As it was such a rare list we launched a VIP event only for those nominated to the list – being part of the 'magic circle' of referrers. This is an awards event where each Leaders List individual who attends receives a small trophy to recognise their entry onto the list.

The evening is a five star event and often attracts UHNW clients also. Last year we boasted a billionaire attendee but really the value is in the intermediaries who attend – the quality is enormously high – dealing with blue blooded UHNW clients globally.

Since then the list has grown each year and modified to reflect changes and the zeitgeist of the year. The research carries on all year with forms on our website for people to fill in online and submit. We also have a fortnightly newsletter with editorial interviews from the private client space which help reveal names and quality of individuals working in private wealth/private client sector.

The Leaders List event starts with a champagne reception, then a fine dinner with Gyles Brandreth as host and we have a set of awards each year for a few star performers called the Citywealth Magic Circle Awards.

Usually we have entertainment and we run these events in Los Angeles and Monte Carlo.

The 2010 awards will take place in London on 13th May 2010.
